2 All State Public Information Officers (SPIOs) as above shall provide information to an applicant within 30(thirty) days of the date of receipt of the request in accordance with the provisions of the said RTI Act, 2005 and Rules, if any there under. If the information which concern the life and liability of a person, information shall be given within 48 hours of the receipt of the request. If no decision is given on a request for information within the time specified here in the above, it will be deemed to be refusal to give information and attracts action under the Act.

3. All State Assistant Public Information Officers (SAPIO) shall supply necessary information whenever it is required by his SPIO. He shall also transmit the application, which he receives from a person seeking information to his SPIO within 5 (five) days of its receipt along with necessary information available with the SAPIO.

This will take immediate effect.
