WHEREAS the Central Government in exercise of the powers conferred by. Sub-section (1) of Section 3 of the Unlawful Activities [Prevention] Act, 1967 (37 of 1967) (hereinafter referred to as "The Act") has declared the National Liberation Front of Tripura (NLFT) & All Tripura Tiger Force (ATTF) alongwith all their factions, wings and front organizations to be unlawful associations with immediate effect vide Notification No. S.O. 5078(E) dated 03.10.2018 (published in the Gazette of India, Extraordinary, Part-II, Section 3, Sub-section (ii) dated 3<sup>rd</sup> October, 2018).

AND WHEREAS vide Gazette Notification No. S.O. 5741(E) dated 15<sup>th</sup> November, 2018, in exercise of powers under Section 5(1) of the Act, the Central Government has constituted the Unlawful Activities (Prevention) Tribunal comprising Hon'ble Mr. Justice Suresh Kumar Kait, Judge, Delhi High Court, for the purpose of adjudicating whether or not there is sufficient cause for declaring the said National Liberation Front of Tripura (NLFT) & All Tripura Tiger Force (ATTF) as Unlawful Associations as required by Sub-section (1) of Section 4 of the Act.

Now THEREFORE, a Notice is hereby given under sub-section (2) of Section 4 of the Act read with Rule 6 of the Unlawful Activities (Prevention) Rules, 1968 and you are hereby called upon to show cause in writing within 30 days from the date of service of this Notice as to why the said **National Liberation Front of Tripura (NLFT)** & All Tripura Tiger Force (ATTF) be not adjudicated for declaring as unlawful associations and why an order should not be made confirming the declaration to the above effect made in the above mentioned Notification.

The objections/reply/written statement, if any, may be filed/delivered within the statutory period of 30 days from the date of service before the Registrar of this Tribunal i.e. the undersigned at Room No. 220, IInd Floor, A Block, High Court of Delhi, Sher Shah Road, New Delhi-110003. In case objections/reply/written statements are in regional or vernacular language, true English Translation thereof should be also attached.

You may cause an appearance on your behalf before the Tribunal on 21<sup>st</sup> January, 2019 at 4:30 P.M. in Court Room No. 6, A Block, Delhi High Court, Sher Shah Road, New Delhi-110003, either through a duly authorized representative or an instructed Counsel/Advocate, whereafter irrespective of your appearance, the Tribunal shall proceed as per sub-Section (3) of Section 4 of the Act.
